**TO ENTER:** The Apollo Fall Gift Card Giveaway (“Sweepstakes”) begins at 9:00 am (PST) October 27, 2016 and ends 5:00 pm (PST) November 27, 2016 (“Sweepstakes Period”). To Enter Automatically: Participant must do one of the following during the Sweepstakes Period:
